

Foreword

True to its original intent, this General Annual Report is the main document describing lessons learned from the European Security and Defence College's Activities. Every year, it offers an opportunity to look back to see what we have accomplished, what should be maintained and consolidated and what should be adapted to face future challenges in a more resilient fashion.

The past academic year, 2018-2019, has been characterised by further steady growth at the College, in terms of types of courses, training activities, participants, network members and tasks for the College. Of course, the biggest growth has been achieved through the new Cyber ETEE platform, which achieved its initial operational capability in this period and will reach its FOC at the beginning of the new academic year, 2019-2020. However, that platform is still in its very early stages and success is far from a given, in light of the complexity of the environment and the multitude of actors involved. Nevertheless, the Cyber ETEE platform is already becoming more active, visible and successful. But as you will read later in this document, significant progress has been made in other domains as well.

This academic year has also been marked by the ESDC Secretariat moving to its new premises. Indeed, almost 10 years to the day after moving to Avenue Cortenbergh 115, we left behind our trusted environment for a renovated building, Rue Bélliard 100. The most important advantage of this new location is the training room that the EEAS has put at our disposal, which is in a lower security area, allowing easier access for our course participants. The new room will slowly be equipped with state-of-the-art technology to support the optimum use of different pedagogical approaches.

During the 2018/2019 academic year, significant work was done on reinforcing civilian CSDP. In the field of training, that was clearly demonstrated by the creation of an EU Civilian Training Group as a special configuration of CIVCOM. The ESDC's civilian training managers have contributed significantly to the preparatory work and will continue to support this group. When MSs requested financial support for the work of the EUCTG, the ESDC stepped in to offer its good services for the administrative management of this

support.

Despite all this good news, it is starting to become clear that in the long term, the current legal set-up of the College will begin to reach its limits. Perhaps the time has come to start thinking about how a more sustainable solution can be found, without impinging further on the CFSP budget. This becomes even more the case, as the administrative burden imposed on the ESDC by the Commission to justify the use of the CFSP budget is likely to increase. The introduction of new IT systems will force us to keep track of a number of key performance indicators to show the effectiveness of what we do. Potentially with little added value to the decision-making process of the ESDC, which is in the hands of the MSs, requests of this type may well increase the staff overhead in the Secretariat.

ESDC mandate

The legal basis for the European Security and Defence College is <u>Council Decision (CFSP) 2016/2382 of 21</u> <u>December 2016</u> establishing a European Security and Defence College (ESDC), amended by <u>Council Decision</u> (<u>CFSP) 2018/712</u> and <u>Council Decision (CFSP) 2019/1297</u>.

The ESDC is organised as a **network** bringing together civilian and military institutes, colleges, academies, universities, institutions and other organisations dealing with security and defence policy issues within the Union. It has a unique setting within the EEAS structures and comprises **four pillars**: the Steering Committee (SC), the Executive Academic Board (EAB), the Head of the ESDC and the ESDC Secretariat.

The Steering Committee (SC)


The SC, composed of one representative appointed by each MS, is the decision-making body of the ESDC. During the last academic year the Committee met five times, with an average participation rate of 20 MSs at each meeting.

Further to its regular tasks and responsibilities in line with the ESDC's legal basis, on 3 June 2019, the Committee decided that the ESDC had both the capacity and the will to support the EUCTG, a CIVCOM configuration tasked with the systematic process of managing CSDP training requirements for civilian CSDP. Starting from September 2019, the ESDC will administer and manage the travel and accommodation costs related to the activities of the CCTs. Careful reallocation of budgetary provisions and the use of the contingency reserve allowed the CCTs to be financed within the existing ESDC budget.

Finally, during the last meeting on 29 June 2019, the MSs discussed how the process of prioritising ESDC training activities could be improved, for example by linking it to the training requirements analysis of the EUMTG and EUCTG.

One issue remained unsolved, namely the status of the UK network members post-Brexit, as this issue is linked to the overall negotiations on this topic.

The Executive Academic Board (EAB)



The Executive Academic Board (EAB), chaired by Dr Mircea Mindrescu (Romania), is the body responsible for ensuring the quality and coherence of the ESDC's training and education activities ¹. The EAB is composed of senior representatives from civilian and military national institutes which are members of the ESDC network. The wider network ² now comprises 157 members, plus eight institutions from outside the MSs with the status of Associated Network Partner. During the last academic year, the EAB met four times. The EAB's main tasks have included evaluating the courses offered under the auspices of the ESDC, updating the standard curricula and developing new curricula for pilot training activities.

In addition, several new Autonomous Knowledge Units (AKUs), which constitute the preparatory part of the courses, were created and older AKUs were updated³. Network partners and EU institutions contributed to the further development of the ESDC's preparatory e-learning tool, which currently consists of learning units and confirmation tests.

The EAB continued to meet regularly in its project-focused configurations:

- the Implementation Group in support of the implementation of the European Initiative for the Exchange of Military Young Officers/Military Erasmus (IG), chaired by Colonel Associated Professor Harald Gell (Austria)
- the Board on Security Sector Reform training (EAB SSR), chaired by Mr Claes Nilsson (Sweden)
- the Working Group on CSDP Missions and Operations-related Training (WGMOT), chaired by Mr Petteri Taitto (Finland)
- the Working Group on the European Doctoral School on the Common Security and Defence Policy (CSDP DocSch), chaired by Dr Sylvain Paile (France)



- EAB.Cyber, chaired by Professor Stavros Stavrou (Cyprus)
- the Working Group on Sectoral Qualifications Framework for the Military Officer Profession (SQF-MILOF WG), chaired by Colonel Gianluca Carriero (Italy)

Implementation Group (IG)

This academic year was a time for breaking records, innovating and reaching the goals set by the previous year's GAREA recommendations. After ten years and 42 IG meetings, the European Initiative for the Exchange of Young Officers inspired by Erasmus reached maturity and increased its footprint, allowing the group to plan and take further action with optimism.





The IG met four times during the last academic year⁴. More 'common modules' were created, taking the total number to 44, with a total value of 122 ECTS. For the second consecutive year, 11 of them were offered as an international semester by the Hellenic Army Academy, Polish University of Land Forces and Romanian Land Forces Academy.

Moreover, a <u>new EMILYO book</u> was authored by Harald Gell, Sylvain Paile and Symeon Zambas. Besides other events, the book was distributed to the Chiefs of Defence in Brussels in October 2018 and to the EUMACS participants in Austria in May 2019.

Following the GAREA 2017-18 recommendations, the IG promoted the creation of an international semester for naval and air force academies, military technical universities and military medical academies, similar to the semester previously created with a focus on land forces. As a result, two new lines of

development (LoDs) were set up, dedicated to the creation of international semesters for the navy and air force.

In addition, important progress has been made regarding the Military Medical Universities; the Hellenic Military Academy of Combat Support Officers has developed a curriculum for the Common Module 'Biosafety and Bioterrorism' – the first such module in the medical field – and the German Bundeswehr Medical Academy in Munich is preparing possible training courses on 'Military Medical Ethics' and/or 'Military Public Health'.

Finally, the IG has started working on a new initiative, namely a forum involving the European military secondary schools. Its main objectives are to bring the schools closer to each other, promote a Common Security and Defence Culture, create common modules (e.g. on EU history, EU core values, Lisbon Treaty, CSDP, etc.) for inclusion in their curricula, exchange best practices, create partnerships and common projects and facilitate exchanges of trainers and trainees.

Security Sector Reform Board (EAB SSR)

Through its meetings, seminars and courses, ESDC EAB SSR continues to contribute to the implementation of the Joint Communication 'Elements for an EU-wide Strategic Framework to support Security Sector Reform' as part of the EU integrated approach to conflicts and crisis. The EAB SSR continues to work in close cooperation with the EU Task Force on SSR.


In 2018-2019 three board meetings, two seminars and six courses took place. The three standard curricula were reviewed and updated: Basic course on SSR (awareness raising), Core course on SSR (advanced/specialised) and In-mission course on SSR (joint and/or specialised training in the field).

As a follow-up to the implementation of the Civilian CSDP Compact and based on the discussions during 2018-2019, the EAB SSR has offered to take on the role of Civilian Coordinator for Training (CCT) for the EU Civilian Training Group (EUCTG), conducting a training requirement analysis (TRA) for the training area of Security Sector Reform during 2019-2020.

EAB.Cyber

Following the creation of the Cyber ETEE platform on 6 February 2018, the first EAB.Cyber meeting took place on 27 September 2018 under the chairmanship of Dr Jochen Rehrl. Professor Stavros Stavrou from the Open University of Cyprus was nominated as the new chair on 7 December 2018. The platform's initial operating capability was announced during a <u>launch</u> seminar on 20-21 November 2018. Its aim is to provide cyber awareness and advanced level courses, including in support of CSDP missions and operations.





Despite of the significant delay in recruiting the cyber team, additional cyber activities were carried out in all cyber domains and at all levels during the academic year, including the first tactical/technical activity (see the Annex).


The EAB.Cyber held three more meetings over the course of the year. The group discussed topics

related to setting up the activities of the Cyber ETEE platform, such as curricula development and quality assurance, and implementation of regular and pilot activities. Following an analysis of the EU cyber ecosystem and the MSs' training requirements on cyber, a new model for training on cyber was proposed. This will involve the Cyber ETEE platform dealing with all cybersecurity domains, such as cybercrime, network information security, cyber defence or external relations.

Working Group on CSDP Missions and Operations-related Training

During the WGMOT meeting in February 2019, several course curricula underwent their regular review and/or were transcribed into the ESDC format, focusing on learning outcomes. Following the endorsement of the 'EU Policy on Training for CSDP' in April 2017, the role of training has increased in importance, especially in conjunction with duty-of-care considerations.

Training Cycle & Duty of Care: Shared responsabilities



CSDP mission areas of operation are becoming increasingly dangerous and civilian casualties have occurred in recent years. As a result, the role of training and proper preparation is becoming more crucial than ever. The training cycle shows how training has become a shared responsibility between MSs, Brussels and the field.


With this in mind, WGMOT, in close cooperation with CPCC security, has created curricula for two courses to help meet the needs of CSDP missions:

a five-day security training course, 'Hostile Environment Awareness Training' (HEAT), and a two-day driving training course, 'Vehicle Safety and 4x4 Driving' (VSD).

Two and a half years after the introduction of the PDT course, the ESDC launched

two surveys. The first was a **level 3 evaluation** to measure the impact of the training on two indicators: firstly, the time needed for new staff members to integrate into the field environment and, secondly, their general understanding, which should enable them to take action and initiatives that contribute to the implementation of the mandate. 80% of the respondents confirmed that PDT helped them to integrate more swiftly into mission life and make more qualified contributions to the implementation of the mandate, while 95% recommended the course for future mission staff.

The second survey, a **level 4 evaluation**, addressed to the mission/operation management, was taken by nine out of the 16 current missions and operations. Again, 30% perceived a difference in the time needed by new staff to integrate into mission life and a difference in the quality of input and performance by new staff in their contribution to the implementation of the mandate.



Working Group on the European Doctoral School on CSDP

The initiative for the European Doctoral School on the CSDP was officially inaugurated on 18 November 2018 during the CSDP Annual Education and Training Conference 2018 organised in Brussels (the Working Group started its activity in the previous academic year, following the first gathering on 8 June 2017). The year 2018 thus marked the start of the operationalisation of the commitments and projects proposed and undertaken by the members on the basis of the initiative's Charter. In September 2018 and March 2019, the first 12 'CSDP PhD Fellows' were selected from the PhD candidates enrolled in one or several network institutions active in the European Higher Education Area.

Up to now, 40 higher education research centres from 16 MSs and European Union agencies and bodies and NGOs have taken part in the CSDP Doctoral School. 107 academic or scientific experts or practitioners in the CSDP area holding a PhD have volunteered to supervise, mentor or take part in the doctoral research of the CSDP PhD Fellows.

The Working Group of the European Doctoral School on CSDP organised a 2019 Summer University and has produced a catalogue of academic and scientific activities on offer to the CSDP PhD Fellows. It has also investigated opportunities for sponsorship for its activities and developed arrangements with the European Defence Agency for partnerships in the conduct of doctoral research.

In addition, several members of the Working Group have submitted a joint application to the EU-funded Jean Monnet Network programme, with the aim of receiving support for the implementation of scientific and training activities for the benefit of the CSDP PhD Fellows. The ESDC Secretariat has developed a <u>webpage on the Doctoral School</u> on its website and a LinkedIn showcase to advertise the initiative and its outcomes. Many of the stakeholders involved in the implementation have actively promoted it in the context of their activities.

Sectoral Qualifications Framework for the Military Officer Profession (SQF-MILOF)

Following the formal establishment of the SQF-MILOF Working Group in June 2018, the MSs' representatives met on a quarterly basis to implement the objectives described in the working programme. During the 2018-2019 academic year, the group focused on issues such as key trends and the characteristics of the military officer of the future in the EU

MSs, the competence profile (what a military officer needs to have learned, from the employer's perspective) and the learning outcomes for the ADVANCED level of learning in order to enable officers to operate at the initial stage of their career.

Furthermore the group agreed on the learning outcomes for the EXPERT level of learning in order to enable officers to operate at the intermediate stage of their career. They also began the process of mapping military qualifications in the MSs, by the means of a questionnaire. In the long run, the answers to the questionnaire will be recorded in a Military Qualifications Database, developed by the ESDC, aiding transparency and facilitating the comparison of qualifications. Last but not least, the group issued a document on 'Quality Assurance Principles Applying to Military Qualifications', thus securing the trust needed among the MSs to ensure interoperability in view of exchanges of officers in training and education events.

Implementation of the ESDC training concept



The ESDC curricula

The ESDC standard curricula focus on achieving learning outcomes in terms of skills, knowledge and competences. The methods used are at the discretion of the training provider, in line with the standards European Qualification set by the Framework for Lifelong Learning (EQF). All activities training with а standard curriculum evaluated using are the Kirkpatrick Model Level 1 evaluation, measuring course participants' satisfaction

(based on an online questionnaire that uses a 1 to 6 scale). Level 3 and 4 evaluations are conducted on a case-by-case basis, based on a decision by the EAB. The ESDC curricula⁵ are available for download on the <u>ESDC website</u>.

As the ESDC is embedded within the EEAS, the course participants benefit from lectures and coaching by high-level speakers and specialised desk officers working within the crisis management structures of the relevant EU institutions and agencies. Another advantage lies within the diversity of the audience itself, as the residential phase of the courses helps to establish interpersonal interaction and trust between participants with different backgrounds, education and profiles, such as military, police, diplomats or other civilians.

CSDP High-Level Course

The 14th edition of the ESDC's flagship training, the CSDP High-Level Course 2018-2019, was dedicated to the French politician Simone Veil, the first woman elected as President of the European Parliament. Attendance of this course is considered as a priority for the senior staff involved in running the CFSP/CSDP at national and European level. As a result, this series saw the highest number of applications in the course's history: 74 participants have been accepted, representing 24 MSs, five EU institutions and agencies, four CSDP missions and operations and two international organisations. The course consisted of four residential modules offered by



Belgium (Brussels), Austria (Vienna), Romania (Bucharest), and Hungary together with EUISS and CEPOL (Budapest). The overall interactive approach of the course provided participants with an in-depth understanding of the different aspects of the CSDP within the larger framework of the CFSP. It also offered a key advantage which is paramount for all ESDC training: the future EU leaders in the security and defence have worked, learned and shared experiences together, establishing connections and networks contributing to the common security and defence culture.

CSDP orientation courses

During the last academic year the ESDC organised 10 CSDP Orientation Courses, a major component of the EU training activities in the field of the CSDP. The course participants were provided with an overview of the civilian and military aspects of CSDP, taking into account the integrated approach and experiential approach via simulation games. The participants had the opportunity to network and share views and perspectives with one another and with professionals in the field of CSDP.

This course is open to third countries and international organisations. Accordingly, relevant activities were also provided in cooperation with DG NEAR, either under the umbrella of the Technical Assistance and Information Exchange instrument of the European Commission (TAIEX) or within the Eastern Partnership panel on 'Security, CSDP and Civil Protection'. The CSDP training programme was organised for the 12th time for the Western Balkans (Austria, Croatia and Hungary) and for

the sixth time in the Eastern Partnership framework (Austria and Romania). Discussions with the European Commission to extend this successful training programme to the Middle East/Northern Africa (MENA) region are ongoing.

Pre-deployment training (PDT)



PDT is to be seen as 'final preparation' for CSDP missions (and operations), complementing national preparatory training activities. It provides participants with the latest relevant information, instruments and policies to enable them to effectively contribute to the implementation of the mission mandate. PDT is no substitute for national training efforts, which remain in the hands of MSs, as clearly indicated in the 'EU Policy on Training for CSDP'. In principle, PDT is always held in Brussels and thus provides a unique opportunity for future mission staff to meet their respective mission/operation points of contact (PoCs) and to get a feel for Brussels headquarters.

The number of PDT participants has increased continuously with each academic year, totalling 531 to date. There has been a trend towards long-term applications, submitted up to three months in advance by seconding authorities. This shows that PDT is gradually becoming an integral part of the recruitment/deployment process. Also noteworthy is the

increase in the number of contracted staff participating in PDT: from nil to 36% within the last two academic years. This development is particularly welcome, since contracted staff have, generally speaking, followed the least amount of training. Their participation in PDT is financed by the missions/operations.

In accordance with last year's survey findings, the ESDC and MPCC have adapted the course programme by introducing briefings on the role and function of the EU Military Staff (EUMS) and Military Planning and Conduct Capability (MPCC) within CSDP as well as pointing out the differences from NATO, C2 structures and intelligence support.

Specialised courses

During the last academic period, 47 specialised courses were offered by members of the ESDC network, focusing on topics including the EU integrated approach, crisis management, strategic planning for mission and operations, gender integration, conflict prevention, mediation and dialogue skills, civilian and military capability development, armament cooperation, hybrid threats, maritime security etc.

At the special request of the EUAM Ukraine Mission, the German Federal Police and ESDC jointly ran an in-mission-training course on 'mentoring and advising in EU crisis management' from 9 to 13 July 2018 in Kyiv, Ukraine.

Pilot courses/activities

During the 2018-2019 academic year, the following pilot training activities were held under the aegis of the ESDC:

The Center for Security Studies (KEMEA), Greece, introduced the migration and security nexus to the ESDC's academic programme by offering the 'Migration Flow, Border Management and CSDP' course from 8 to 12 October 2018 in Athens, Greece. The pilot course addressed the migration-security nexus with a special emphasis on the MENA region and Africa. It also discussed the integration of European migration policies in the broader framework of interventions under the Global Strategy for the European Union's Foreign and Security Policy. A second iteration of this pilot course will be organised during the 2019-2020 academic year, taking into account the lessons learned from the first activity and focusing on the learning outcomes and the implementation of the EU views and concepts of human security in the wider framework of external action. The standard course on the migration and security nexus will be designed in cooperation with other

training experts from the ESDC network and will also use the lessons learned from the pilot training offered by another Greek institution, the Multinational Peace Support Operations Training Center (MPSOTC), in the second part of the academic year of reference.

On 17-18 November 2018 the Austrian Institute for European and Security Policy (AIES) organised the course '**The Civil-Military Dimension of Cyberattacks**' under the auspices of the ESDC. This pilot training aimed to analyse the preventive and reactive management measures currently being taken by the international community to minimise the impact of cyber challenges.

Under the auspices of the Cyber ETEE platform, the Digital Security Authority of Cyprus (DSA) ran a course entitled '**Cybersecurity Organisational and Defensive Capabilities'** from 13 to 15 May 2019 in Nicosia (Cyprus). This first tactical/technical course covered topics related to capabilities, standard operating procedures, risk assessment and management, incident reporting and threat hunting, malware analysis and reverse engineering.

Taking into account the recommendations made during the CSDP Annual Training and Education Conference 2019, Trinity College, Dublin (Ireland) decided to organise the pilot course '**Improving performance in CSDP missions**', in cooperation with the ESDC. The course was held in Dublin from 7 to 9 January 2019 and focused on increasing CSDP operational effectiveness by enhancing communication, gender and cultural skills. The course was supported by a digital role-playing game that was developed in the recently completed project 'GAP', which was funded by the European Commission and supported by the ESDC and its network partners.

Following the conduct of the first pilot '**Advanced Modular Training'** (AMT) during the 2017-2018 academic year, the main lessons confirmed that this course covers a training gap and thus meets a real need of the MSs. The AMT course was redesigned in a second iteration, imposing mandatory attendance for all modules and reorganising it as two modules (AMT Module 1 - Integrated Approach and AMT Module 2 – CSDP Operations Planning, with two options AMT2a – political-strategic level and AMT2b – military strategic

level) while keeping the CSDP Orientation Course as a prerequisite to attend AMT. The second pilot AMT was co-organised, in two iterations (the first iteration in March-April and the second in May-July), by the EUMS and ESDC together with Ireland, Greece, Italy and Sweden.

The pilot training activity **'Strategic Communication in Security and Defence**' was held in Bucharest on 25-29 March 2019 in the framework of the Romanian Presidency of the Council of the EU. It involved 78 communication experts (representing ten MSs, two EU structures and five CSDP missions). Held in partnership with the Edward M. Kennedy Institute for Conflict Intervention – National University of Ireland Maynooth/NUIM (Ireland) and the Romanian Diplomatic Institute (Romania) and receiving the support of the EEAS – Strategic Communications, the course highlighted the role played by strategic communications in a rapidly changing landscape, shaped by intensive digitalisation, the emergence of innovative technologies, the proliferation of online disinformation and the continued erosion of trust in public institutions.

Following a training requirements analysis conducted by the EU Military Staff and Multinational Logistics Coordination Centre (MLCC), agreed by the EU Military Committee, the ESDC organised a pilot modular training solution composed of two courses: the '**EU Logistics Fundamental Course'** and the '**EU Logistics in Operations Course'**. The aim of the EU Logistics Fundamentals Course (2-5 April 2019) was to provide participants with foundation knowledge of EU logistics policies, principles, concepts, and procedures in CSDP missions and operations. The course laid the foundation (as a prerequisite) for more in-depth operational discussions that were held in the following course, the EU Logistics in Operations Course (8-12 April 2019).

In close coordination with the CPCC, the ESDC organised a specialised training course entitled **'Improving interviewing skills and the selection procedure for civilian CSDP Missions**' on 8-10 April 2019 in Brussels (Belgium), which focused on EU recruitment, interviewing and selection procedures. Based on the ongoing evaluation of the course outcome, the CPCC intends to develop this specific training in order for it to be run as standard training under the ESDC; further options are currently being assessed.

The ESDC and the 'Institut des Hautes Études de Défense Nationale (IHEDN, France) ran the course **'EU Energy Security: Implications for the CSDP**' on 15-16 May 2019 in Brussels (Belgium), aiming to give participants an understanding of the notions and concepts related to energy security, and its implications for the CSDP.

The Multinational Peace Support Operations Training Center (MPSOTC, Greece) organised the training course **'Crisis Response to Mass Migration and Refugees Flows**'. Held in Kilkis (Greece) on 27-31 May 2019, the course aimed to prepare civil servants, military and law-enforcement officers from the MSs, relevant EU institutions and agencies, and CSDP missions and operations to effectively address the phenomenon of mass migration to the EU and identify causal factors and the tools to mitigate it in the CSDP context. An additional aim was to achieve a higher level of cooperation between stakeholders. The evaluation of this session will allow the ESDC network members to take the next step towards establishing an ESDC standard course on this very important but sensitive topic in the context of both the EU's internal security and CSDP. The issues include human migration, mass movement of people and the influx of refugees/asylum seekers, integrated border management and the influence of those factors on the EU's internal and external security.

Cooperation between the EU and the **United Nations** is continuing through ESDC training. UNLOPS supported the courses on SSR, gender and human rights, protection of civilians, recovery and stabilisation peacekeeping, mediation and the CSDP High-Level Course. On behalf of the EEAS, the ESDC is currently conducting an online

survey to map the training already being provided by EU MSs to participants in UN missions. In addition, the ESDC contributed to the document on 'Reinforcing the UN-EU Strategic Partnership on Peace Operations and Crisis Management: Priorities 2019-2021'.

The Head of the ESDC participated in a panel discussion during the EU-UN-regional organisations seminar organised at the UN headquarters in New York (US) in the framework of the Romanian Presidency of the Council of the European Union.

Cooperation with **NATO** has been ongoing as well. Numerous NATO staff members have attended ESDC courses. The ESDC participated in the 'NATO-EU Cyber Security Collaboration and Initiatives' panel of the NATO Maritime Interdiction Operational Training Centre's (NMIOTC, Greece), the 3rd Conference on Cyber Security in the Maritime Domain (10-11 April 2019) and the 'A robust Cyber ecosystem: Savvy Cyber workforce development' panel of the 5th NATO Cyber Defence Smart Defence Projects Conference in Lisbon (PT) on 16 May 2019.

The Head of the ESDC participated at the 48th NATO Conference of Commandants (CoC) entitled 'Leadership in NATO - Challenges for the Future' held at the Centro Alti Studi per la Difesa (CASD) in Rome (IT) from 28 to 30 May 2019.

Furthermore, the ESDC SQF-MILOF WG initiated cooperation with the NATO Task Group on Individual Training and Education Development (TG IT&ED), with a view to finding areas of synergies, while avoiding unnecessary duplication. NATO TG IT&ED is developing a 'Feasibility study on the NATO Interoperability Framework', under the auspices of the NATO Training Group. The NATO Interoperability Framework and the EU SQF-MILOF have partially overlapping aims and a common audience: military officers from the 22 MSs that are members of both the EU and NATO. The intention is to keep both products coordinated and aligned.

The ESDC has twice participated in a videoconference meeting with colleagues from **NATO Centres of Excellence**: Combined Joint Operation from the Sea, Confined and Shallow Water, Naval Mine Warfare; and with the NATO Maritime Interdiction Operational Training Centre. In this setting, the ESDC shared the details of relevant courses and conferences where reciprocal invitations could be envisaged, and provided information and points of contact aimed at enhancing interaction among EU and NATO networks of training providers. More specifically, the NATO Maritime Interdiction Operational Training Centre (NMIOTC) participated in the course 'Challenges of Securing Maritime Areas for the European Union', organised in Constanta (Romania) from 21 to 24 May 2019. The ESDC continued to support activities in third countries, facilitating the neighbourhood policy and the association process of countries to the EU. During 2018-2019, training providers from the ESDC network have included numerous third countries in CSDP training activities⁶. The ESDC and its network partners continued to provide training for our closest neighbours, the **Western Balkan** partners (Albania, Bosnia and Herzegovina, Kosovo⁷, North Macedonia, Montenegro and Serbia) and the countries of the **Eastern Partnership** (Armenia, Azerbaijan, Belarus, Georgia, Moldova and Ukraine). For the first time, subject-focused training was provided to the Eastern Partnership community: training on conflict analysis, held in Yerevan (Armenia) and training on disaster relief, held in Bucharest (Romania). The success of the training triggered an initiative to provide further activities in the areas of hybrid threats, cybersecurity and strategic communication in the near future. This initiative was launched during the Eastern Partnership panel meeting on 17 May 2019.

From 26 to 30 November 2018, the ESDC organised the third **EU-ASEAN** Orientation Seminar, in cooperation with the EEAS-CMPD and with the support of the EU delegation in Indonesia. For the first time, this seminar was organised in South-East Asia (Jakarta, Indonesia), bringing together 42 participants from nine ASEAN countries and the EU MSs. This event led to closer cooperation with the Indonesian National Defence University, with the result that an ESDC training manager participated in the Indonesia International Defence Seminar 2019 (in July 2019), delivering a lecture on EU counter-terrorism and cyber defence.

Recently the ESDC also received delegations from a number of countries and international organisations, including Indonesia, Vietnam, Ecuador, the Republic of Korea and the League of Arab States, seeking cooperation on training opportunities relevant to the EU's foreign policy.

ESDC engaging in international fora

The ESDC took part in the 7th annual meeting of the European Association of Peace

Operations Training Centres (EAPTC) in Belgrade on 16-18 April. The ESDC provided presentations in three panels, on the 'Role of the EAPTC', 'Conflict Analysis and Mediation Skills for Training and peacekeepers', and 'Missions Leadership Training'. Democratic values, the rule of law, international

humanitarian law, human rights and gender perspectives were emphasised as a starting point for CSDP training, as stated in the EU Training Policy for CSDP. The participants underlined the importance of the EAPTC maintaining strong links with relevant EU structures.

For the first time the annual international Military Academic Forum (iMAF) was

organised back-to-back with an IG meeting, since the purpose of the forum is to support the work of the group in implementing the decision of the EU Ministers of Defence to further develop the harmonisation of European officer training, the development of a European Security and Defence Culture and interoperability. 131 participants from 22 nations worked on the development of an International Semester in the field of naval and air force officer

education, the evaluation of existing programmes and the identification of further financing options for exchanges and cooperation projects. In addition, three new Erasmus agreements were signed between the University of Pisa – which runs the academic programmes of the Accademia Navale Marina Militare in Livorno – and the Theresan Military Academy, the Polish Naval Academy and the Portuguese Naval Academy.

On 5 June 2019, the Head of the ESDC delivered a keynote speech at the **7th Annual Interagency Interaction in Crisis Management and Disaster Response Conference** organised by the Crisis Management and Disaster Response Centre of Excellence in Sofia, Bulgaria. The conference serves as a platform for information and knowledge exchange

and promotes coordination of actions among key stakeholders, both military and civilian, in the domain of crisis Management and Disaster Response domain.

On 19-20 June 2019 the ESDC took part in the **11th Annual Meeting of Human Rights and Gender Adviser Focal Points in CSDP Missions and Operations**. The advisers stressed the importance of ensuring gender and human rights as an essential part of basic training and generic pre-deployment

training, not only through the ESDC's PDT, but also through training offered in individual MSs. Advisers reported mixed levels of previous knowledge among new mission personnel on gender, human rights, and international humanitarian law, and especially on how to apply this perspective to other tasks. Existing ESDC training on a gender perspective in support of mission and operations, and on investigating and preventing sexual and gender-based violence in conflict environments, was highly appreciated.

For the first time, all (military) services participated in the **European Union Military Academies Commandants' Seminars (EUMACS)** in Austria in October 2018. In Romania in June 2019, EUMACS Rectors, Commandants and Superintendents from 19 MSs were briefed about the ESDC and the Military Erasmus Initiative by the ESDC Head and the IG Chair. In total 132 participants took part in the events. Both events gave the leaders of our EU military institutions the opportunity to come closer, and to discuss and decide together on the joint steps to be taken towards the harmonisation of our basic military officer education. With this broad participation, the EUMACS meeting could in future become a useful platform to provide further input and guidance for the Implementation Group.

During the **Indonesia International Defense Science Seminar 2019 (IIDSS)**, hosted by Indonesia Defense University (UNHAN), the ESDC, representing the EU and the EEAS, delivered a lecture on 'Shifting International Politics and Future Global War on Terror' -European Union Policy on Counterterrorism, Cyber & Hybrid Threats, for more than 600 participants and distinguished guests from numerous countries. The seminar was a great opportunity to strengthen the EU's existing cooperation with Indonesia and international partners to address global security issues. The ESDC, with the support of the European Union Delegation (EUDEL) in Indonesia, had numerous side meetings, strengthening the

links and cooperation in the field of peacekeeping operations and CSDP with several official institutions' and authorities' representatives in Indonesia, such as the Indonesia Defence (UNHAN) University and **PMPP-TNI** (Peacekeeping Training Center).

Links with EU agencies

The ESDC continued to work in close cooperation with the **European Union Institute for Security Studies (EUISS)**, a key member of the ESDC network. During the last academic year the EUISS continued to provide, on a regular



basis, lectures for residential training. In particular, the EUISS provided highly qualified speakers during the 14th CSDP High-Level Course 2018-2019 and co-organised the 4th residential module in Budapest from 3 to 7 June 2019. As has become a yearly tradition, the EUISS also supported the ESDC Alumni meeting in February 2019 by organising a highly appreciated panel. In turn, the Head of the ESDC participated as a moderator in a workshop on civilian CSDP co-organised by the Finnish Presidency of the Council of the European Union and the EUISS in July 2019.



The **European Defence Agency** remained committed to supporting the ESDC's residential training. The EDA had a leading role in the establishment of the Cyber ETEE platform. Under the CSDP DocSch, the establishment of

funded doctoral research fellowships at the EDA in the form of two internships is in its final phase of approval. In addition, the ESDC, in cooperation with the EDA, has been monitoring the development of CD TEXP⁸, which will ultimately serve as the host platform for all Cyber ETEE training courses.

⁸ CD TEXP is a project undertaken and funded by EDA. It's currently at the build-2 phase, and it is anticipated to migrate under ESDC's administration once completed. The platform itself is currently, and will continue to be, hosted at the Portuguese Military Academy.



During the 2018-2019 academic year, the ESDC has further strengthened its cooperation with the **European Union Agency for Law Enforcement Training** (CEPOL). CEPOL co-organised, with EUISS and the National University of Public Service (NUPS),

the fourth module of the ESDC CSDP High Level Course in Budapest from 3 to 7 June 2019. Finally, the ESDC participated in the Steering Board of the 'CEPOL Knowledge Centre (CKC) on CSDP Missions', which provides relevant training on this subject for its target audience.

Cooperation with the European Union Agency for Cybersecurity (**ENISA**) was enhanced during the last academic year. ESDC staff participated in various events such as 'Bonding EU Cyber Threat Intelligence' on 5-6 November in Brussels, and the 'Artificial Intelligence'



conference on 3-4 June 2019 in Athens (Greece). Finally, the first joint training activity of ENISA and the ESDC will be run in September 2019, in Crete (Greece).

ESDC engaging with Commission-funded projects

During the academic year, the ESDC participated in the Steering Group meetings for **Europe's New Training Initiative – ENTRI III.** Following the closure of the project, the



ESDC took over and currently hosts its deliverables within the ESDC ILIAS e-learning platform and <u>website</u>. The content is now available <u>on-line</u>. Moreover, ESDC personnel contributed a cybersecurity section to the fourth

edition of the handbook <u>'In Control – A Practical Guide for Civilian Experts Working in</u> Crisis Management Missions'. As a member of the **European Union Police and Civilian Services Training (EUPCST)** Steering Group and Steering Committee, the ESDC provides insight, overall harmonisation and support for the implementation of the EUPCST project and activities. EUPCST will fit into wider EU developments in civilian CSDP, harmonising its content



internally in the consortium and externally with relevant stakeholders. When designing training activities and exercises under EUPCST, synergies with the existing ESDC curricula will be explored.

The **Gaming for Peace (GAP) project**, an interactive e-learning project, developed by a consortium headed by Trinity College Dublin (Ireland), has focused on the development of soft skills relevant for working in the international and multi-cultural environment of peace operations. The project has been successfully completed this spring and the e-learning module is now accessible on the ESDC e-learning platform. Also, based on the results of the project, a pilot course '**Improving performance in CSDP missions**', supported by a digital role-playing game developed during GAP, has been offered by Trinity College, Dublin under the ESDC.

On 2 October 2018 the ESDC took part in a panel at the conference 'Shaping the Future of Peace Training in Europe and Beyond' in Vienna (Austria), organised by the Commission-funded project **peacetraining.eu**. The plenary session on 'The Role of Peace Training, Peacebuilding and Prevention in Europe's Common Security and Defence Policy' addressed the role of conflict prevention and peacebuilding training as part of the implementation of the CSDP and the CFSP. It also looked at the accomplishments and challenges of CSDP by addressing the training challenges beyond the operational, institutional and conceptual debates.

The Head of the ESDC gave a keynote speech at the kick-off meeting of the ECHO consortium on 25 February 2019. This Commission-funded project is one of four projects focusing on cybersecurity in the European Union. The consortium consists of some 30 members, forming a 'network of cyber centres' focusing on matters including governance, certification, early warning systems and training curricula.

Conferences and seminars

On 14-15 November 2018, the ESDC together with the CMPD, EUMS and CPCC hosted the **CSDP Annual Training and Education Conference 2018** in Brussels (Belgium) bringing together staff from CSDP missions and operations (Deputy Heads of Mission/Mission Commanders, Heads of Training Units, Heads of Human Resources as well as Press and Public Information Officers), training experts from various ministries from the MSs, representatives of relevant EU institutions and agencies, as well as training providers in the crisis management field. The conference combined three events, namely the ESDC Network Conference, the Annual Meeting on Training of CSDP Missions & Operations Personnel, and the EU Annual Military Training and Education Seminar. The 160 participants had the opportunity to analyse lessons identified from CSDP missions and operations, discuss recent CSDP developments and emerging policies and explore possible synergies.

The seventh edition of the **ESDC Alumni Seminar** was jointly organised by the ESDC and EUISS in Brussels (Belgium) on 21-22 February 2019. The 2019 annual seminar was held under the auspices of the Romanian Presidency of the Council of the European Union and provided the setting for a discussion on the European Union's aim to implement its global strategy on security and defence in order to become a global actor. The ESDC Alumni Association – Association Alumni CESD ASBL, also provided its traditional support to the success of the annual Alumni Seminar by organising a conference where ESDC alumni were invited to share their knowledge and expertise.

The **Initial Operating Capability of the Cyber ETEE platform** within the ESDC was officially announced during a <u>two-day conference</u> on 20 and 21 November 2018 at the Museum of Fine Arts in Brussels. The event was opened by the Minister of Defence of Cyprus, Mr Savvas Angelides, who underlined the importance of European initiatives in this field. During the conference, the main stakeholders, namely the European Defence Agency, the EU Institute for Security

Studies, the European Hybrid Centre of Excellence, the CERT-EU and Europol, organised and hosted one panel each.

The event was supported by another publication from the Austrian Ministry of Defence's in its handbook series. The <u>'Handbook on Cybersecurity</u>' was presented during the conference and at the same time tabled at the <u>Foreign Affairs Council on 20 November</u> 2018. In the foreword, HR/VP Ms Federica Mogherini underlined the importance of the establishment of the Cyber ETEE platform, which will be implemented in close cooperation with the EU institutions and agencies, the MSs and NATO. She stated: 'In a global context where security is never just a matter of traditional defence and where the real world merges with the cyber world, cybersecurity is a collective responsibility. It calls on each and every one of us, citizens of Europe, to invest in the most powerful tool we have to exercise our sovereignty, advance our interests and stand by our values: our European Union.'

On 10-11 November 2018, 163 participants from 25 military institutions of 13 MSs (AT, BE, BG, CZ, CR, CY, FR, GR, IT, NL, PL, PT and RO), as well as the United States Military Academy (West Point, US) and the Royal Military College Saint-Jean (Canada), attended the festivities to mark the tenth anniversary of the European Initiative on the Exchange of Young Officers, inspired by Erasmus (EMILYO), which were hosted by the Hellenic Army, Naval and Air Force Academies in Athens, Greece. The participants had the chance to run the authentic Athens Marathon, row the Trireme Olympias, and attend a full day of lectures and analyses on the battles of

Marathon, Thermopylae and Salamis, gaining an insight into their crucial importance in European history.

In 2018-2019 the EAB SSR organised two expert seminars including ongoing work on the implementation of the 'EU-wide strategic framework to support Security Sector Reform' and its key elements for training purposes. The seminars were open to MSs, the EAB SSR, the EU Task Force on SSR and EEAS desks doing SSR-related work. The **first EAB SSR seminar** on 25 September 2018 in Brussels (Belgium) emphasised the need for more expertise to analyse the security sector and a more conflict-sensitive approach. To support that requirement, EU SSR matrices (mapping, analysis and learning) are being produced

in a number of countries. The discussions at the seminar also covered ongoing countering and preventing violent extremism (C/PVE) measures by the EU, e.g. the progress of Iraq EUAM including SSR mapping as well as the ongoing EU-Interpol-NATO (Stability Policing, Centre of Excellence) battlefield evidence project for 2018-2021.

The **second EAB SSR seminar** on 17 June 2019 in Brussels (Belgium) looked at how to utilise SSR/Rule of Law programming as a conflict prevention measure. Links were made to EU and UN efforts to develop joint indicators for justice and security actors in fragile contexts as part of strengthening conflict prevention engagement and early warning systems. Indicators and SSR matrices in different contexts such as Mali, Burkina Faso, and Benin were also examined. Among other topics, 'SSR as a conflict prevention measure focusing on C/PVE and gender' based on best practices from a newly released OSCE Handbook was presented. The findings were linked to the broader discussion on Rule of Law and SSR and how that perspective could enable better analysis.

The ESDC, together with the Egmont Institute, organised the **2018 Global Strategy PhD Prize**. In November 2018, the jury awarded the prize to Dr Iulian Romanyshyn for his dissertation on <u>'The European Union – An Effective Actor in Multilateral Arms</u> <u>Negotiations?</u> '

The **eLearning and Software for Education Conference (eLSE)**, organised by the Romanian Advanced Distributed Learning Partnership Centre under the patronage of Carol I National Defence University and the ESDC, held its 2019 edition at the University POLITEHNICA of Bucharest (Romania).



eLSE Conference, Bucharest 11-12 April 2019

The purpose of this annual international scientific conference was to enable academic, research and corporate entities to boost the potential of technology-enhanced learning environments, by providing a forum for exchange of ideas, research outcomes, business cases and technical achievements. The ESDC, apart from sponsoring the conference, gave a keynote speech presenting the new initiative of the European Doctoral School on CSDP, with a focus on encouraging researchers to centre their research on the Common Security and Defence Policy.

Implementing EU policies

EU integrated approach to external conflict and crisis and conflict prevention

The EU Global Strategy for Common Foreign and Security Policy (CFSP) emphasises that the integrated approach to external conflicts and crisis to build resilience, support sustainable peace and foster human security continues. This integrated approach is the central theme of several ESDC courses, including its CSDP High-Level and Orientation courses as well as the Advanced Modular Training. Conflict prevention continues to play an essential role in training, and the strengthening of skills on conflict analysis, mediation, negotiation and dialogue is an integral part of the ESDC training programme. Although the training is often skill based, the ESDC, in close cooperation with the EEAS, supports by linking it to the EU policy framework.

The Civilian CSDP Compact

The implementation of the EU Global Strategy has enabled significant steps forward to be taken on military and defence issues. The Civilian Compact, agreed on 19 November 2018, sets the **strategic guidelines for the strengthening of civilian CSDP**, including political commitments on e.g. training and recruitment linked to pre- and in-mission training efforts for national experts in accordance with the EU Training Policy for CSDP. One way in which this work was supported was the establishment of the EU Civilian Training Group (EUCTG).


Implementation of the EU Training Policy for CSDP

The EU Policy on Training for CSDP (from April 2017) underlines that CSDP training should reflect and promote EU principles and policies by supporting democracy, the rule of law, human rights and international law. The principles derive from the Treaty, other sources of EU policy and Council Conclusions (for example on hybrid threats), UN resolutions (including UNSCR 1325 and subsequent ones for gender), and from international humanitarian law and refugee law (IHL) and law on combatting sexual and gender-based violence. The EU principles form the basis for all CSDP training, with special references given to leadership and pre-deployment training (PDT). As CSDP training is a

shared effort, with MSs being responsible and the EEAS providing support, the **ESDC acts as a linchpin by being the main entity, at EU level, for CSDP training according to the policy**. As a result, the ESDC continues its commitment to support the implementation of the EU Policy on Training for CSDP.

EU Civilian Training Group (EUCTG)

The EUCTG was set up as a configuration of CIVCOM in the beginning of 2019. The EUCTG appoints one or more centres of excellence to be responsible for various civilian training areas, aiming to strengthen the proper functioning of CSDP missions and drawing on existing CSDP policy, lines of operation of civilian CSDP mandates, lessons identified, and previous training analyses. The institute(s) or the academy (or academies) in charge, i.e. the 'Civilian Coordinators for Training' (CCTs), will conduct a training requirement analysis (TRA) for the selected area. Some training areas may be mainly civilian, but civ-mil synergies should be encouraged and the work should be aligned with that of the so-called 'discipline leaders' of the EUMTG.



EU CSDP Training cycle and deliverables

Following the role outlined in the EU Training Policy for CSDP, the ESDC, in close cooperation with the EEAS ISP and the EEAS CPCC, supports the ongoing work of the EUCTG. This has included drafting, and assisting with the implementation of, the EUCTG Strategic Guidance on CSDP Civilian Training. From 1 September 2019, the ESDC will also

manage the travel budget for the CCTs and support the training requirement analysis (TRA) work through some of its specialised working groups. EAB SSR has offered to be the CCT for the training area of Security Sector Reform.

EU Military Training Group (EUMTG)

Ever since the establishment of the EUMTG, the ESDC has been active and has directly contributed to the various work strands, attending regular EUMTG meetings, contributing in various workshops to carry out training requirements analysis for discipline leaders (Civil-Military Cooperation, Multinational Logistics, Cyber Defence, Military Role in Border Management) and helping to design integrated, feasible training solutions.

The recently reviewed EUMTG Terms of Reference now clearly acknowledge the role of the ESDC, in paragraph 14: 'The European Security and Defence College (ESDC) plays a central role in coordinating and conducting the CSDP military training at EU level. Therefore, in accordance with the legal basis of the ESDC and the role set out for it in the EU Policy on Training for CSDP, the ESDC will be invited to attend the meetings, and support the work, of EUMTG. The ESDC may act as a facilitator between the EUMTG and the EUCTG as far as civilian/military training is concerned.'

European Union Maritime Security Strategy

In line with the provisions of Action A 5.1 of the <u>European Union Maritime Security</u> <u>Strategy (EUMSS) Revised Action Plan</u>, the ESDC mainstreamed the Maritime Security Strategy and its corresponding Action Plan as a **horizontal subject across several standard courses**. A specialised course on 'The challenges of securing maritime areas for the European Union' was offered during the last academic year by Greece (April 2019 in the context of Military Erasmus), Bulgaria (April 2019) and Romania (May 2019) with a total of 79 participants.

In line with the provisions of Action 5.5 and 5.6 of the aforementioned EUMSS Action Plan, a group of six naval academies are working on the content of an international semester which also covers cybersecurity, in the framework of Military Erasmus.

Women, peace and security (WPS) and gender mainstreaming

On 10 December 2018 the Council adopted conclusions on women, peace and security (WPS). The EU strategic approach to WPS underlines the need for systematic integration

of a gender perspective into all fields and activities in the domain of peace and security, and throughout the EU's external action in general.

The ESDC cooperates closely with the EEAS to implement the WPS agenda, gender and human rights in CSDP through curricula review, course design and the work in various EAB configurations and working groups, as well as through the EEAS gender and human rights task force. Ongoing and new developments in WPS, gender and human rights are incorporated in specialised courses on topics such as a comprehensive approach to gender in operation, a gender perspective in CSDP, and investigating and preventing sexual and gender-based violence in conflict environments. Such developments are also integrated in more generic courses such as PDT, the OC and the HLC.

During the iMAF 2018 at NUPS in Budapest it was agreed to find possibilities to devote more attention to gender issues within European basic officer education. As a result, the first Erasmus-Staff Training Gender Seminar was organised by the Theresan Military Academy in Wiener Neustadt from 27 to 29 September 2018, with 17 participants coming from ten military institutions and the ESDC. The aim of the seminar was mainly to reflect on possible measures to increase the number of female cadets recruited for basic officer education; a <u>'white paper</u>' was issued listing the measures identified.

Finally, during the IG meeting on 9 November 2018 in Athens the ESDC Secretariat suggested setting up LoD 10 on Gender Mainstreaming. At the following IG meeting in Brussels the first LoD 10 meeting took place and the EEAS Principal Advisor on Gender gave a keynote speech.

Resource management

The ESDC Secretariat

In terms of human resources, the staff assigned to the ESDC Cyber ETEE platform was reinforced with three SNEs, from Germany, Romania and Greece. The recruitment procedure for the platform's fifth post is still ongoing and the sixth and final post should be filled in 2020. In addition, the contracts of two SNEs, from Austria and Romania, came to an end in July 2019. Their successors were seconded by Romania.

However, even though the ESDC has increased its activities to meet the needs arising in both the MSs and the missions and operations, the recruitment of SNEs has proven to be a challenging procedure with an impact on the implementation and management of the action. The 14 SNEs currently come from only seven MSs – and that will be even further reduced to six MSs at the end of the 2018-2019 academic year.

In addition, during the last academic year the ESDC received two interns, who contributed to various work strands, such as social media, data analysis and administrative support for training activities and events. It must be highlighted that following a recommendation from the GAREA 2017-18, the ESDC finally managed to establish a paid internship scheme.

Financial management of the ESDC and its activities

The ESDC is financed via an operating grant from the CFSP budget, managed by the FPI. It has the necessary legal capacity in order to fulfil its tasks. The Head of the ESDC is responsible for its financial and administrative management.

In February 2019, an external financial audit was carried out on the previous financial year. For the second year in a row, no factual findings arose from the external auditor's verification of the action's expenditure (expenditure coverage ratio 80.17%). The results in the expenditure verification report reflect that the organisational and financial management set-up for the implementation of the action delivered the desired output. Subsequently, the ESDC Steering Committee granted discharge to the Head of the ESDC.

ESDC web footprint



During the last academic year the ESDC created a new <u>website</u> (https://esdc.europa.eu/) with an integrated ENLIST⁹ application. These new tools allow more visibility, data analysis and userfriendly functionality. Apart from the academic calendar and articles on ESDC events and activities, users can find all the

ESDC standard curricula approved by the MSs, ESDC publications, and information on the ESDC's governance and structure. In addition, the ESDC makes regular and structured use of social media, allowing immediate interaction with its audience.

Recommendations

The Steering Committee is invited to agree to the following recommendations for improving the functioning and the activities of the ESDC:

GENERAL

- Revise the ESDC's prioritisation process, so that the priorities set in the EUCTG and EUMTG can be better taken into account;
- Encourage MSs to distribute ESDC vacancy notices to interested staff and ensure a better geographic representation in the ESDC Secretariat;
- Ensure a good geographic spread of the staff working at the ESDC Secretariat by encouraging all MSs to nominate candidates for the open positions and to allow seconded staff to stay in their positions for a sufficiently long time;
- Ensure a good spread of courses offered by MSs over the academic year;
- Ensure a balanced mix of civilian, police, diplomatic and military personnel on ESDC courses, when appropriate;
- Encourage all MSs to actively participate in the activities and meetings of all ESDC bodies (Steering Committee, Executive Academic Board and its project-focused configurations);
- Encourage MSs that have military secondary schools to participate in the new EU Military Secondary Schools Forum (EUMSS).

EAB

 Encourage network members to increase the adult learning methods in their courses, by shifting the focus from theoretical presentations to interactive, scenariobased, practical exercises in small groups, making use, where relevant, of modern technology;

- Encourage MSs to expand the use of tutoring and mentoring activities as part of their courses, thus ensuring coherent and real-life-based approaches to learning so that participants can apply the skills they acquire to their jobs;
- Encourage MSs to distribute the information about the ESDC training offers widely so that all interested staff from ministries and national authorities are properly informed and are able to submit course applications in time;

IMPLEMENTATION GROUP

- Encourage all MSs to adopt the existing international semester, preferably as a whole, in the curricula of their army academies;
- Create an international semester for naval and air force academies, military technical universities and military medical academies in line with the international semester developed for land forces;
- Provide the opportunity for medium- to long-term exchanges of trainers/staff with a view to enhancing the exchange of best practices;
- Develop joint degrees for basic officer education;
- Encourage all MSs to adopt the legal framework which regulates the exchanges of young military officers (cadets).

SECTORAL QUALIFICATIONS FRAMEWORK FOR MILITARY OFFICERS

- Encourage MSs to implement the SQF-MILOF (upon finalisation) in their national military training and education system, by referencing relevant military qualifications to SQF-MILOF learning levels;
- Invite MSs to develop common training for officers at 'Initial' and 'Intermediate' career levels, in line with the agreed learning outcomes;
- Task the ESDC Secretariat with developing a Military Qualifications Database (supported by the ESDC website), which will help MSs to compare similar

qualifications, thus supporting the implementation of the SQF-MILOF at national level.

WGMOT

- Create a standardised course curriculum for 'induction training', in close cooperation with CPCC, to ensure the complementarity of content with PDT;
- Promote in-mission training as a cost-effective high-precision instrument, which allows training to be tailored to specific needs and requirements at low cost;
- Develop the role of WGMOT following the creation of the EU Civilian Training Group (EUCTG) and the adoption of the Strategic Guidance on CSDP Civilian Training in June 2019.

EUROPEAN DOCTORAL SCHOOL ON CSDP

- Identify academic and scientific research experts who would be willing to supervise or mentor doctoral research on CSDP;
- Communicate on the Doctoral School to all stakeholders;
- Support efforts to identify and apply for external support opportunities, notably funding opportunities;
- Promote the European Doctoral School in the MSs as an initiative contributing to the common strategic culture;
- Identify and share training and research opportunities offered within and outside the network of the Doctoral School on the CSDP for doctoral researchers;

EAB SSR

• Take up the role of the CCT for SSR in the EUCTG (as nominated by SE and led by FBA), with the aim of moving the training agenda forward through TRA work;

- Build further on positive results from the SSR seminar series on the role of SSR in conflict prevention;
- Further explore the need for additional training in context and actor analysis as a tool for implementing the SSR framework;

CYBER ETEE PLATFORM

- Explore potential agreements with major stakeholders in the EU's and in the MSs' cyber ecosystem;
- Explore further funding opportunities;
- Establish quality assurance for cyber-related activities;
- Establish a self-assessment evaluation tool for participants after the training;
- Develop e-Learning stand-alone courses and modules;

ESDC IT TOOLS

- Standardise login procedures in all ESDC platforms: website, ENLIST, ILIAS and in the future with CD TEXP, preferably using ECAS central login functionality;
- Further promote content developed by third parties and hosted by the ESDC;
- Update the content of all AKUs in order to include interactive elements;
- Create new AKUs, for example on the functioning of the ESDC and on the CDPF (Cyber Defence Policy Framework).
