## General How? When? Why?

- Discussed at the last day of 53<sup>rd</sup> IG Meeting
- Why?
  - Most of the academies host cadets from other countries
  - They provide them with their knowledge
  - ...and other facilities!
- We probably need two Questionnaires:
  - Evaluation for each module
  - Evaluation for all the rest (facilities, administrative, health, meals, etc.)

## The Questionnaire for the Module Evaluation

- 1st Draft → 3rd Draft
  - Hellenic Army Academy
  - Hellenic Authority for Higher Education
  - Universities (Athens, Crete, Thessaloniki, etc)
  - Academies (TMA, etc)
  - Other sources (Professors, Officers, etc.)

#### **Evaluation for each Module**

- Suggestion → One questionnaire per instructor?
- One module needs more than one questionnaire if we need to "evaluate" all the instructors! Therefore
- IF YES → We should use one per instructor per module
- IF NOT → JUST one questionnaire per module is enough!

#### **Evaluation for each Module**

- The Questionnaire is divided into 6 main topics
  - The course/module (1-10)
  - Assignments (11-16)
  - The Instructor (17-25)
  - The Laboratory (26-29)
  - Me, the cadet (30-32)
  - Remarks/Comments (33-34)

In total 34 questions

- The scale 1 to 6 is chosen in the questionnaire:
  - 1 (Extremely Disagree) 2 (Disagree) 3 (Somewhat Disagree) 4 (Somewhat Agree) – 5 (Agree) – 6 (Extremely Agree)

#### The course/module (1-10)

- 1. My English skills were sufficient to follow the lectures \*
- 2. The scope of the course was clear \*
- 3. The syllabus met the objectives of the course \*
- 4. The course material was well organized \*
- 5. If needed, the main book(s) or the notes were satisfactory (includes up-to-date knowledge, up-to-date literature, and provides a high level of knowledge)
- 6. If needed, the educational material (books, notes, bibliographic sources, etc.) that was used helped the better understanding of the topic
- 7. If needed, the educational material ("textbook", notes, additional bibliography) was provided in a timely manner
- 8. If needed, the bibliography or the recommended textbooks were available in the academy's library (in printed or digital form)
- 9. The level of the course and the workload were excessive and caused me a lot of stress/pressure (Except for the modules where "pressure" is part of the learning outcomes) \*
- 10. There is transparency in the assessment criteria \*

#### **Assignments (11-16)**

#### (Answer only if individual/group projects are assigned)

- 11. The assignments in association with the expected learning outcomes were satisfactory
- 12. The assignments were clearly described by the instructors
- 13. The instructors provided me with the necessary support in order to complete the assignment
- 14. The instructors' comments on my assignments helped me improve the way I learned and studied
- 15. The assignment helped me to implement my existing knowledge
- 16. The deadline for submitting or presenting the assignments was reasonable

#### The Instructor (17-25)

- 17. The assignments were clearly described by the instructors \*
- 18. Organizes and presents well the syllabus of the course/module (use of Information and Communication Technologies ICT, e-learning Platform, e.g., Moodle, etc.) \*
- 19. Succeeds in stimulating interest in the subject of the course \*
- 20. Analyses and presents the concepts in a simple and interesting way using examples \*
- 21. Encourages the cadets to ask questions and generally promotes dialogue during the course, in order to develop their judgment \*
- 22. Was consistent with his/her obligations (presence in the course, timely correction of assignments or laboratory reports, hours of cooperation with cadets) \*
- 23. Is generally accessible to the cadets \*
- 24. Understands the special and demanding program of the cadets \*
- 25. I am overall satisfied with the course instructor regarding the overall organisation and teaching of the course \*

#### The Laboratory (26-29)

(Answer only if the course includes lab exercises)

- 26. The lab course level is appropriate
- 27. The notes for the laboratory exercises are adequate and organized
- 28. The basic principles of the experiments/exercises are well explained and there is sufficient guidance
- 29. The equipment of the laboratory is sufficient

#### Me, the cadet (30-32)

- 30.I was present at all lectures and/or labs (consider yourself absent when you are in the classroom, but you are not "attending" the course)
- 31.I systematically turn in written assignments/exercises respecting the deadlines
- 32.I dedicate to the study of this course/module
