<u>Mandate</u> for the entire Implementation Group – issued by all EU Minsters of Defence – in November 2008:

- 1) <u>Harmonisation of the European Union basic officer education</u>: End-state: All EU Member States have parts of their basic officer education in common (ideally one semester or more) within the respective service or for all services with respect to the national specialisations.
- 2) <u>Increase interoperability among the Armed Forces of the EU Member States</u>: End-state: Based on point 1, during future EU operations officers from EU Member States do not have any problems to work together (based on their common education, language skills, etc.).
- 3) <u>Promote a Common Security and Defence Culture</u>: End-state: Before graduation, all European Union officer cadets & midshipmen are convinced that sticking together within the EU is the only way to manage the threats and challenges.
