New Rules

ESDC will co-finance the activities by paying grants at the end of the activity, instead of paying reimbursements.

ESDC will **not pay a reimbursement of the expenses** but will **provide a lump-sum amount of money** to contribute to the costs of the activity.

Training Institution will not send invoices or receipt to justify the expenses to the ESDC to receive the payment of the grant.

The Training Institution shall collect, record and keep all the financial documents related to the activity to be shown at request of the Head of the ESDC, or of the audit or other EU or other investigation national authority, for 10 years, accordingly to the EU regulations.
